DATES: This Sweepstakes will be open from March 31, 2025 at 12:00am EST until April 13, 2025 at 11:59pm EST (collectively, the "Entry Period.")

WHO MAY ENTER: Open to all My Lenovo Rewards members who are (a) legal residents of the fifty (50) states of the United States, District of Columbia and Canada, and (ii) 18 years of age or older or have otherwise reached the age of majority on the state/country in which they reside.
