

# My Lenovo Rewards Gear Up and Go Sweepstakes

## Official Rules

No purchase is necessary. Void where prohibited.

Entry into this Sweepstakes constitutes your acceptance of these Official Rules.

### 1. Entry dates

The My Lenovo Rewards Gear Up and Go ("Sweepstakes") begins at 10:00 a.m. ET on July 21, 2025, and ends at 11:59 p.m. ET on August 24, 2025 ("Entry Period").

### 2. Eligibility

The Sweepstakes is open to all registered members of the My Lenovo Rewards program ("My Lenovo Rewards") who are (i) legal residents of the fifty (50) states of the United States (including District of Columbia) or Canada, and (ii) 18 years of age or older, or have otherwise reached the age of majority in the country in which they reside. THIS SWEEPSTAKES IS VOID WHEREVER RESTRICTED BY, WITHOUT LIMITATION, FILING OR REGISTRATION REQUIREMENTS, OR IS OTHERWISE PROHIBITED OR RESTRICTED BY LAW. Individuals employed or contracted by Lenovo (United States) Inc. ("Sponsor"), its parent or affiliated companies, subsidiaries, and/or advertising and promotion agencies (collectively, "Sweepstakes Parties") at any time during the Entry Period, and members of their immediate family or persons living in the same household, are not eligible.

### 3. How to enter

During the Entry Period, eligible entrants ("Entrants") may enter the Sweepstakes by (a) visiting the MyLenovo Rewards dashboard located under "My Account" on the Lenovo.com website, and (b) exchanging 1,000 of Entrant's available rewards points for one (1) entry into the Sweepstakes. Entrants may exchange as many points as they have in their account for the duration of the Entry Period (1,000 rewards points per entry). Entrants must follow all instructions provided by Sponsor to enter. All entries must be received by 11:59 p.m. ET on August 24, 2025.

### 4. Alternative Method of Entry (AMOE):

To enter the Sweepstakes without taking the above actions, Entrants must be a My Lenovo Rewards member and must fill out this form with their full name, complete address, and email address. Entrants may obtain one (1) entry per day via this online method. All Email entries must be sent during the Entry Period, and received on or before August 24, 2025, to be eligible for the Sweepstakes.

By submitting an entry, each Entrant agrees that his or her entry complies with these Official Rules. Each Entrant also agrees that Sponsor may disqualify the Entrant from the Sweepstakes if Sponsor believes, in its sole and absolute discretion, that Entrant and/or any entry are not compliant with these Official Rules. If Sponsor rejects any reward

exchange or entry for any reason, such entry will be disqualified and will not be considered valid. Entries may only be made according to the methods described above. The use of any automated means to enter (including but not limited to the use of any robot, script, macro, or other automated services) is not permitted and any such entries earned will be disqualified. Only eligible entries received by Sweepstakes Parties will be eligible. Illegible, unintelligible, incomplete, or garbled entries will be disqualified.

## **5. Ownership of entries**

By submitting an entry, each Entrant agrees Sponsor shall own the entry submitted (including all copyrights thereto and all rights embodied therein) and that it and its designees may exploit, edit, publish, use, adapt, modify, copy, disseminate, or dispose of any entry, the concepts embodied therein or any elements thereof, online, in print, film, television, or in any other media for advertising and promotional purposes without compensation or notification to the Entrant of any kind, except as prohibited by law.

## **6. How to win**

At 11:59 p.m. ET on August 24, 2025, the Entry Period will be closed in its entirety. On or about September 1, 2025, one (1) winning Entrant will be randomly selected from the pool of eligible entries received during the Entry Period to receive the prize specified below. Winner will be notified by Sponsor via email. Note: You are not a winner of any prize until you have been verified as a winner by the Sponsor. Decisions of the Sponsor are final in all matters relating to this Sweepstakes.

## **7. Prizes**

There will be a total of one (1) winner during the Sweepstakes, who will receive the following prize package: one (1) Legion 5 Gen 10 AMD (15") with RTX 5060 (ARV \$1,534.99), one (1) Lenovo Professional Bluetooth Rechargeable Mouse (ARV \$41.99), one (1) Lenovo Select Targus 16-inch Mobile Elite Backpack (ARV \$32.99) and one (1) pair of Lenovo E310 True Wireless Stereo Earbuds. Prizes are non-transferable, with no cash redemption or equivalent. Sponsor reserves the right to substitute a prize or prize component of equal or greater value should a prize or any component of a prize become unavailable. Except as specifically provided herein, prize packages do not include insurance, personal expenses, incidental charges, gratuities, or any other items not specifically described in these Official Rules. Under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages,

including attorneys' fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and Entrant further waives all rights to have damages multiplied or increased.
