

**MOTOROLA Trade Promotion FIFA Consumer Competition 2026**  
**Terms and Conditions**

**Entry into a Promotion**

1. Information on how to enter and prizes form part of these conditions of entry. Entry into this Promotion is deemed to be acceptance of conditions. Motorola Mobility Australia Pty. Ltd. [ABN 86 139 208 361], Leve 15, 40 Mount Street North Sydney NSW 2060 (hereafter referred to as the "**Promoter**"), reserves the right to modify these conditions at any time.
2. Entry is open to legal residents of Australia, who have reached 18 years of age or (in the event that a winner is under 18 years of age, the prize will be awarded if the consent of his or her legal guardian is first given and obtained) the applicable age of majority in their jurisdiction as of the beginning of the Promotion Period, and who are not an employee of or domiciled with an employee of the Promoter or its affiliated companies, their advertising and promotional agencies (an "**Eligible Entrant**"). The Promotion is subject in all instances to compliance with applicable law.
3. The Promotion will commence at [00:01am AEST on Monday 4 May 2026] and end at 11:59pm AEDT on Friday 15 May 2026] ("**Promotional Period**").
4. To be eligible to enter, individuals must during the Promotional Period:
  - Purchase one (1) motorola signature, motorola edge 70, or motorola edge 70 fusion handset from a Participating Retailer and submit a valid entry in accordance with the entry requirements specified by the Participating Retailer, including providing valid proof of purchase where required. (each an "**Eligible Entry**").
  - Participating Retailer is JB Hi-Fi ("**Participating Retailer**").
5. Limit of one (1) Eligible Entry per Eligible Entrant, regardless of the number of eligible products purchased.
6. This promotion is a game of chance. Skill plays no part in determining the winner.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. Incomplete, indecipherable or illegible entries will be deemed invalid.
9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

**Prizes and Draws**

10. The Promoter's decision is final and no correspondence will be entered into.
11. All entries will be validated by the Participating Retailer. Each valid entry will be allocated a unique entry number. Personal entrant information remains with the Participating Retailer prior to the draw.

12. The draw will be conducted by Motorola Mobility Australia Pty Ltd using the unique entry numbers provided by the Participating Retailer.

13. Participating Retailer will have two (2) winners selected.

14. The draw may be observed by an independent scrutineer or otherwise documented in accordance with regulatory requirements.

15. Motorola will provide winning entry numbers to the Participating Retailer, who will identify the winner from internal records and confirm eligibility. Winner details will be then be provided to Motorola for notification and prize fulfilment.

16. Winners will be notified directly and in writing (via email) by Motorola as soon as practicable following the draw and in any event within twenty-one (21) days of the determination of the results.

17. Winners must confirm acceptance of the prize in writing within fourteen (14) days of notification and provide any information reasonably requested to verify eligibility. Failure to do so will result in the prize being deemed unclaimed.

18. If a prize is unclaimed, a redraw will occur:

  - Eligible Entrant must be responding for obtaining, at their own cost, any required visas, ESTA approvals, permits or other travel documentation necessary for travel to the United States.
  - Eligible Entrant must comply with all applicable government, airline and venue requirements, including any travel advisories or entry restrictions in force at the time of travel.

The Promoter reserves the right to delay, modify, substitute or cancel the prize, or any aspect of the prize, if the competition or prize fulfilment is impacted by circumstances beyond the Promoter's reasonable control. 31. Members of the Promoter who provide incorrect or fraudulent information are ineligible to participate in the Promotion. The Promoter reserves the right to request at its sole discretion, appropriate photo identification or other documentation in order to confirm the members' eligibility to enter and claim a prize, before issuing a prize. If the documentation required by the

Promoter is not received by the Promoter or its nominated agent, or the identity of the member has not been verified or validated to the Promoter's satisfaction, then that member will be deemed invalid.

34. 35. The Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend the promotion, and/or if necessary to provide an alternative prize or prizes to the same value as an original prize or prizes, subject to any written directions under applicable State or Territory legislation.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under other consumer protection laws in the State and Territories of Australia (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence) whatsoever which is suffered, including for any: personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the competition.
37. If any of the provisions of these terms and conditions are held to be invalid or unenforceable in whole or in part that part shall be severed from the remainder of the provisions and the validity of the other provisions and the remainder of the provision in question shall not be affected.
38. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the

Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
